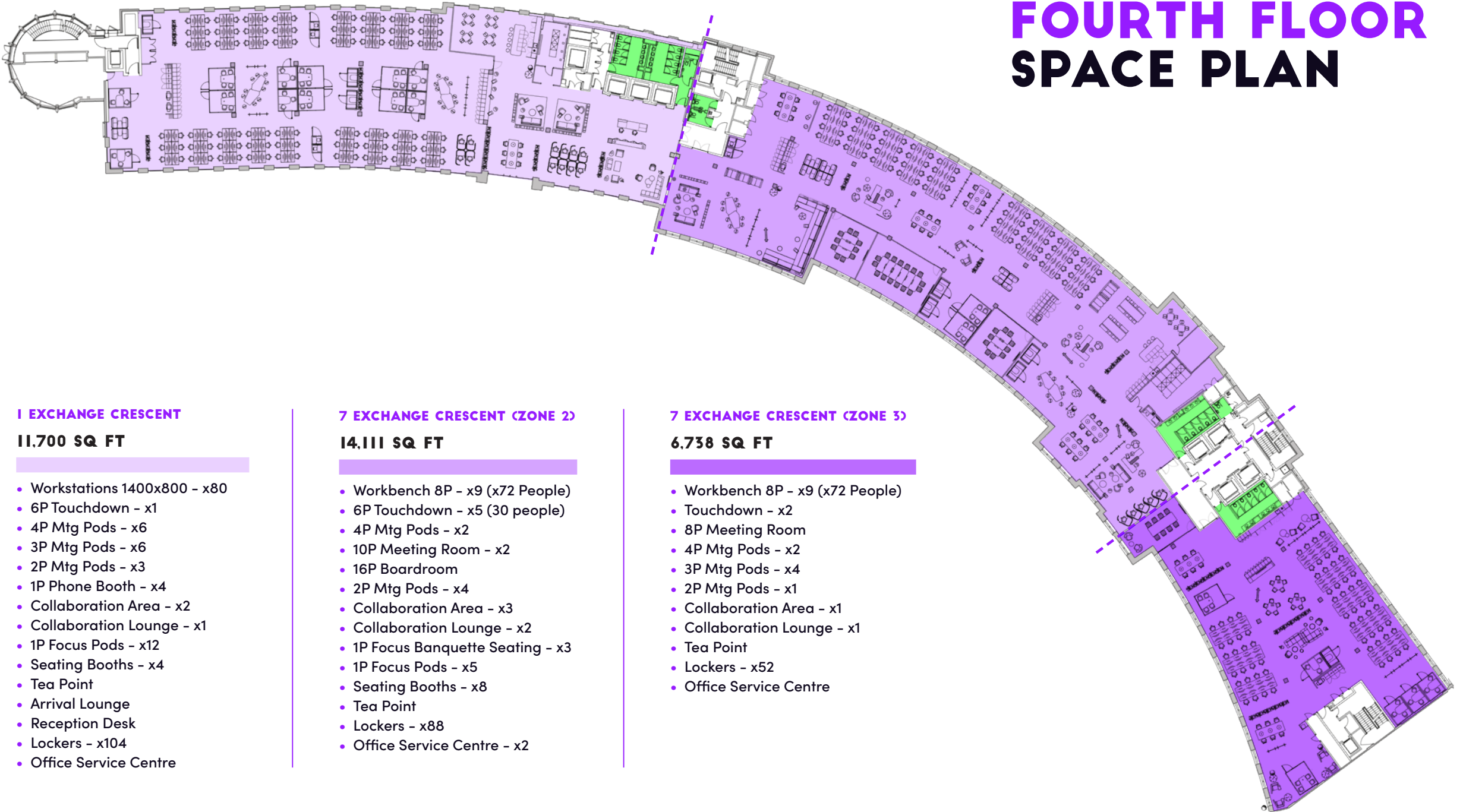


FOURTH FLOOR SPACE PLAN
